Refund Policy

The candidates who have taken admission in UG Courses may request for refund of fees after applying in writing for cancellation of their admission to the course. The refund of fees as applicable will be made after 30th day of cancellation of admission. The percentage of fee for the course will be refunded to the candidate on cancellation of admission after deducting charges as follows:

Category	Percentage of Refund of fees*	Point of time when notice of withdrawal of admission is received in the HEI
(1)	100%	15 days or more before the formally notified last date of admission
(2)	90%	Less than 15 days before the formally notified last date of admission
(3)	80%	15 days or less after the formally notified last date of admission
(4)	50%	30 days or less, but more than 15 days after formally notified last date of admission
(5)	00%	More than 30 days after formally notified last date of admission
